Remembering Jim Godden

Jim Godden was my friend and a good one too. Not just mine but almost everyone he came into contact with could say the same. Someone who not only spoke his mind but backed his words with action. If it needed doing he was there, along with whoever he could muster with his own persuasive manner and the FGA owe him a debt of gratitude.

Gardening was one of his great pleasures, no doubt an inheritance from his Dad who was also an allotment holder back home down Southampton way. He himself arrived in Flitwick with his wife Anne in the early 90's and because of his being banned from his back garden which was Anne's domain, very soon took on an allotment which is where we first met, then another and later, yet another so that between us we had well over10% of Station Road! It came as no surprise that he soon became the Allotment representative. The Council then was a very different animal to the more cooperative and amenable one of today. Jim got things done but it was abrasive hard work. Thankfully, it's a better atmosphere now.

From early on he grew a wide variety of crops, always trying something new and different. One plot was dedicated to fruit and much of another to cut flowers, daffodils, gladioli and dahlias which were exhibited every year at our Spring and Summer Shows with much success and it didn't end there, his hanging baskets of fuchsias and begonias were ever present. The remaining ground obviously produced much for the table but not only as, again, success was had in the vegetable Show classes. To him it didn't matter if he wasn't placed first, what mattered was that he had an exhibit, without entries what is the purpose of a show and if his entry came second or third that was a bonus. Of course mention must be made about his pumpkins. He was in regular competition with several members over time, each year the weights getting heavier and heavier: one year the scales could not give an exact reading as the 300 pound limit was breached! He actually won the trophy 12 times but the name Godden appears 13 times as on one occasion he entered two fruits, one in his name and a second for his wife Anne - she won!

His contribution to the FGA cannot be overstated. Joining the Executive Committee was only a first step; soon after, the post of Trading Secretary sadly became vacant and he took on the responsibility of deciding and ordering not only what commercial items were stocked in the Seedbox but also all the seasonal items. Plug plants were brought on in his crammed greenhouses at home, trips made to the auctions in Spalding and transported in members cars back to Flitwick whilst more were obtained and nurtured for the Plant Sale outside the Bank on Station Square for which he himself made the market stall; once even, a potato delivery was organised by him on the phone from the car as Anne was driving them to Scotland on holiday! When the Treasurer's position also unfortunately became available it was he that took on the mantle, intending to hand one or the other over as soon as a suitable volunteer could be recruited; it's a sad reflection that it took three years for that to happen. For all that time he carried on with the other needs of the posts, organising

the annual stocktake just before Xmas, bagging and weighing of potatoes and onion sets during the closed period, overseeing the Monday Mob that kept the Seedbox properly stocked with compost and own packs throughout the year, the list of jobs performed behind the scenes is endless; what is amazing is that for the most part, all of this was happening before he had even retired, he was still a working man but his planning skills meant that he managed somehow, even to the extent that when we were still opening on Friday nights he had a regular standing order with the local fish and chip shop that he could collect his evening meal after closing the Seedbox. It was necessary Friday nights were stopped because with the lack of support from the membership- he acknowledged even he couldn't keep doing both days of a weekend. He cared about the FGA but had a life outside of it. In the few quiet times at the Seedbox the discussion could well be model railways, golf, foreign holidays and my particular passion, football, whilst at home Match of the Day was apparently sacrosanct.

Returning to his involvement with the FGA he had one more role to play. When I stepped down from the Chair for various reasons there was really only one person who could take over, wasn't there? Under his stewardship we have seen the Seedbox protected and by circumstance, the allotments, in relation to the construction of the retirement village being built on the old leisure centre site; not a bad legacy. Allotment Representative, Trading Secretary, Treasurer, Chairman, he did it all and I give a big thank you to my departed friend.

Do you grow blueberries?

Have you been disappointed with the results? If so, it's my bet you're using the wrong compost! Blueberries, cranberries, azaleas, rhododendrons and camellias are acid-loving lime-hating plants. Ordinary compost is not good for them, pale leaves with yellow veins, small fruit, flowers that drop before maturity - all are signs of mulching or feeding with ordinary or homemade compost/proprietary products. Come to the Seedbox for ericaceous compost for your best results.

I wish to open this annual report with a tribute to our recently passed Chairman, Mr. J.G Godden known to one and all as Jim, a stalwart of the FGA. Thanks for all you did Jim and rest in peace.

The issues concerning the Seedbox are still not fully resolved but thanks to the efforts of various Committee members we should have an agreed lease with the Council in place very soon.

The Care Home development is taking longer than expected and slightly impacting our operations but the contractors are also very obliging in assisting us with access and improvements. We will get there ultimately.

The Shows go from strength to strength; exhibit quality and public feedback continues to rise; long may this continue, whilst the annual quiz is more than meeting its target of the support for the above and we are therefore able to make donations to our preferred local charities.

The trading environment within the Seedbox whilst having been revamped, with stock ranges being reduced and reorganised is still necessarily ongoing. Watch this space.

Thanks to a few members stepping up to be keyholders we are able to open most Saturdays; without these it would be difficult to operate as much as we do but the perennial problem remains, we need more members to be more involved which requires both volunteers and being personally approached.

Financially, the FGA is healthy, physically less so, a fact borne out by the fact that we are considering an outing for later in the year to an RHS Garden but without numbers it will be self driven/car shared.

Overall, a curate's egg but with a little more support next year could be free-range!

AGM TRADING REPORT

I would like to start off with thanking everyone for Another great year of trading and the support from all members, none of this would be possible without the team of volunteers that continue to keep this Association running.

This year we made the unanimous decision to go Peat-Free trading in 2024. We understand that leaving the products we know and love can be hard but if we don't adapt then we will not be able to continue to run and there is a legal requirement that we will not be able to sell Peat based produce at some point this year. With this in mind please keep your eyes out for our special offer "make your own compost" consisting of; 1 x bag of PEAT 3kg Blood fish and bone and 3kg Horticultural sand.

Some of you will have noticed that we ran potato orders very tight this year to help reduce the wastage seen in previous years and I believe it has been a huge success and its great to see everything being snapped up. Thank you to all members that pre-ordered and pre-paid for their potatoes, onions and shallots and I wish you and your seeds the best success this year and look forward to your repeat order at the end of this year.

Treasurer's Report 2023

First up, a big thank you to everybody who has helped with the FGA and the Seed Box this past year. We do rely on volunteers to keep everything running on a shoestring, and keep prices low, so thanks to you all! Despite the challenging economic environment and inflated costs, we have managed to balance the books.

- Total Sales were slightly down (£19,155 this year vs £20,101 prior year).
 Sales of Compost, Potatoes and Seeds remained strong but there was a reduction in sales of General gardening items.
- This year we did a lighter restock than 2022 so Purchase costs were lower (£17,057 this year vs £21,728 prior year).
- As Sales, Purchases and Stock movement broadly balanced out, the overall Trading Surplus was similar to last year (£4,716 this year vs £4,434 prior year)
- Shows and Social events raised combined funds of £206 (vs £245 prior year).
 As last year, Quiz profits were shared with Keech Hospice and Flitwick
 Combined Charities both of which thanked the FGA warmly.

 After taking into account additional expenses, such as bank charges, telephone costs and rent, the Net Surplus was £2,731 in 2023 (vs £2,037 prior year).

I am conscious that we have recorded a 'surplus' the last few years but this may be a little misleading. The FGA holds a large amount of stock (£40,670 at Year End) and this has a major bearing on the bottom line. For 2024, the intention is to have a review of the stock items and their value, particularly some of the older items. If we do write down stock value, this would potentially lead to a one-off deficit next year so I'm giving prior warning!

Last, but certainly not least, a special 'Hats Off' from me to Jim, who will be very much missed by us all in the FGA. He was an inspirational leader as FGA Chair, and taught me everything I knew when I joined as Treasurer! I will add my appreciation for the energy, time and commitment that Jim put into everything that he did – what a great example to us all.

Flitwick Gardeners' Association RULES

As at 20th April, 2023

- 1.Name: The name of the Association shall be the Flitwick Gardeners' Association.
- 2.**Objects**: To promote the interests of gardeners and allotment holders and to take joint action for the benefit of members; To arrange for instruction, trips, and shows and to distribute literature pertaining to these objectives.
- 3.**Members**: The Association shall consist of persons who are resident within the Town of Flitwick and nearby towns and villages.
- 4. Fees and Subscriptions: There will be a joining fee for all new members and for lapsed members applying to rejoin after membership has lapsed in accordance with Rule 5. Every member shall pay an annual subscription, payable in advance of the due date of January 1st. Members receiving the magazine by Royal Mail shall pay an annual surcharge. The amount of the joining fee and of the annual subscription and the surcharge shall be set annually by the Annual General Meeting.
- 5.Arrears: Any member who is in arrears with his subscription at the time of the AGM shall be deemed to have ceased to be a member unless explanation is given to the Committee in writing of extenuating circumstances.
- 6.**Officers**: The Officers shall be Chairman, Treasurer, Secretary and Trading Secretary. All Officers shall be ex-officio members of the Executive Committee.
- 7.**Committee**: The affairs of the Association shall be conducted by an Executive Committee of not less than eight members. A quorum shall be of not less than five members. Vacancies arising may be filled by co-option on the authority of the Executive Committee. All members shall retire annually, and a fresh Committee be elected at each Annual General Meeting. Retiring members shall be eligible for re-election.
- 8.**General Meetings**: An Annual General Meeting shall be held during March or April each year. 14 days' notice shall be given, and a quorum shall be ten members. At the meeting shall be presented the Reports from the Officers and a set of Examined Accounts and the Officers and Executive Committee Members elected for the coming year. The Financial Year shall be from the First of January until the Thirty-First of December. The Secretary shall have authority to convene an Extraordinary General Meeting at any time after giving the due notice, but he shall always do so if so, requested by no less than ten general members in writing.
- 9.**Discussions at Meetings**: No party political or sectarian discussions shall be raised, or resolutions proposed, at any Committee, sub-committee or General Meeting of the Association

- 10.**Funds**: The Committee shall open an account with a Bank selected by the Executive Committee in the name of the Flitwick Gardeners Association and all monies received from any source on behalf of the Association shall be passed through the Treasurer or their nominee to be paid into the account. Payments of value over £100 should be authorised by two members of the Executive Committee, one of whom shall always be the Treasurer or their nominee; payments below this value can be authorised by one Officer only.
- 11. Association Accounts: The end of year accounts shall be examined by an examiner who is not a member of the Executive Committee and submit their report to the Annual General Meeting.
- 12. **Affiliation**: The Association shall affiliate itself to any suitable Group providing it is non-political or non-sectarian and shall pay such annual affiliation fees as may from time to time be prescribed. Nominees may be appointed to represent the Association at the various organisations as determined from time to time.
- 13. Offences: The Executive Committee may terminate the membership of a member whose conduct is proved to their satisfaction to be detrimental to the Association or to the interests of their fellow members. Any charge against a member must be communicated in writing. An appeal from a decision of the Executive Committee may be made to a Special General Meeting on the requisition in writing of three members to the Secretary who will convene an Extraordinary General Meeting as soon as possible to hear the appeal.
- 14. Conversion, Dissolution, Etc: The Association may be converted into a registered society, or may be dissolved, or these rules may be amended by a two-thirds majority of those present at a General Meeting convened with the due fourteen days' notice. The notice convening the General Meeting shall list the reason(s) for calling it.
- 15.Matters arising not covered by these Rules: Any matter not covered by the rules may be dealt with by the Executive Committee at its sole discretion.
